












Programme Highlights

Admissions Requirements 入學要求

Admission is open to applicants who hold bachelor degrees from accredited institutions in any area of undergraduate studies. Applicants should have achieved the GPA 2.8 (equivalent to 75-77 out of 100) or above in the Bachelor's degree studies. Bachelor degrees in finance, economics, applied mathematics, applied science, statistics, computer science, engineering, or other quantitative fields are preferable. An additional result of GRE or GMAT is preferable.

Other admission requirements will be in accordance with the University Admission Regulations on Master's Degree. Please refer to the website of the Graduate School for more details.





The University of Macau (UM) is founded in 1981, UM is the only public comprehensive university in Macao with a high degree of internationalization. English is the main medium of instruction at UM. It has over 11,000 students from around 50 countries and regions. Over the past 40 years, the number of registered students at UM has increased to over 11,000 from several hundred when the university was first founded. With dual emphasis on teaching and research, UM has become the preferred choice of outstanding students from around the world. UM is ranked in the 201-250 bracket in the 2022 Times Higher Education (THE) World University Rankings, with a global ranking of No 5 in International Outlook, No 38 in the THE Asia University Rankings, No 39 in the THE Young University Rankings, and No 1 in the Association of Portuguese Speaking Universities. In the 2021 Quacquarelli Symonds (QS) World University Rankings, it is ranked No 322.

The Faculty of Business Administration (FBA) is a distinctive flagship full-service business school with key responsibilities in business and management education and in nurturing the leadership and entrepreneurial talents for the development of Macau and beyond. Recent years has seen FBA make tremendous inroads in achieving its goal of becoming a global leading business school.
